#### Release of Liability

- I am making the decision to allow the musher to participate in the race fully aware of the inherent risks associated with dog mushing and mid-distance dog racing. For example, the musher will be traveling in remote parts of Alaska, under canine power, unassisted and alone in arctic conditions. Arctic conditions can include bitter cold, driving rain, lost trails, and dangerous encounters with Alaska wildlife. These conditions will be further compounded by the musher's expected sleeplessness. It is impossible to identify all potential risks the musher might encounter while participating in the Willow Jr 100—that is the nature of this event and dog mushing generally. In other words, and most importantly, I understand participating in the Willow Jr 100 could result in serious injury to the musher, their dogs and equipment.
- By signing this liability waiver I hereby acknowledge that I am aware of the inherent risks and dangers, both known and unknown, associated with the Willow Jr 100 Dog Sled Race, and despite these risks I agree for the musher to participate.
- By signing this liability waiver, I assume full responsibility for any injury to myself, the musher, the dog team. I release all Willow Jr 100 personnel from any injury, loss or damage that may occur during participation with Willow Jr 100 and its associated activities.
